The Fund's objective is to provide Ordinary (Ord) shareholders with a high level of income, with the potential for income and capital growth, and to provide Zero Dividend Preference (ZDP) shareholders with a pre-determined final capital entitlement of 127.25p per ZDP share on the planned winding up date of 1 July 2024.


Investment style: Value

Aberforth are value investors who buy shares in companies that they calculate to be selling below their intrinsic value. This is determined through detailed financial and industrial analysis, combined with a valuation approach that focuses on both stockmarket and corporate worth.

Investment commentary

After a torrid March for stockmarkets, company updates and macro-economic data in April confirmed a substantial downturn in activity. However, equities responded positively to further government support for the economy and to evidence that the pandemic was being brought under control. The FTSE All-Share rose by 4.9%, but, having proved more resilient in March, lagged the NSCI (XIC)'s return of 11.5%. It was also affected by evidence that Covid-19 would put pressure on the dividends of even the largest companies. The Fund secured a return of 10.4%, on which style factors had negligible effect.

Cancelled dividends are not confined to the FTSE 100. Companies that have chosen to cut, cancel or defer their dividends stood out among the losers. These included news publisher Reach, food producer Bakkavor, International Personal Finance, STV and windows and doors manufacturer Eurocell, whose under-performance was compounded by a placing of new shares. More broadly, equity issues have started. There have been several placings of up to 20%, taking advantage of relaxed pre-emption rules, but the bigger rights issues will likely come in early Summer.


More positively, against the backdrop of improved sentiment, those stocks that had suffered most in March tended to perform most strongly in April. Amongst these were RM, a supplier of education materials to schools, brick manufacturer Forterra, bus and rail operator Go-Ahead and mining royalties company Anglo Pacific. Elsewhere, industrial textile manufacturer Low & Bonar performed strongly following EU competition clearance for the takeover by Freudenberg.


